

To: City of St. John's and all council members

I am writing to you to express our community concern with the road configuration on Shea Heights. This is an excellent project and will increase property values once this is completed, however the configuration has caused the community to request change.

The City of St. John's held consultations on this road change but community members reported due to poor communication only a few attended and the only issue discussed was cost to residence, not traffic calming.

The intersection of Linegar Avenue at Warford Rd. has been changed. This was a direct downhill flow into Linegar Ave prior to the change. In the attempt to calm traffic the road North of Warford Road on Linegar Avenue, was narrowed extremely. The intersection was narrowed as well. This narrowing results in large vehicles occupying both lanes to make the turn. Larger vehicles (school buses) will have to reverse, or go over the curb to make a left turn. There are residences of Shea Heights who are disabled and live in this area. With this design there is not enough room for two large vehicles to pass with a wheelchair. The sidewalks will not be ploughed in this area in the winter so this is putting disabled residences in danger using the roadway.

On Linegar Ave. North of Warford Rd the road has been narrowed to extreme. Our community is outraged with this plan. It is a traffic hazard as it is proposed. We have been told it is within tolerances which, is questionable, but either way the community has spoken loudly and wishes this to be changed.

We held a community meeting with Councillor Collins and City engineers present. Councillor Collins spoke on why the road was changed and the community members listened. The community members responded with true situations as to why this configuration has failed. The roadway has been measured, and reviewed by numerous parties. Councillor Collins insists it is within the legal limits for a roadway and a community is insisting it be changed.

Our committee was struck with the sole purpose of bringing this issue to the City for resolution. The Honourable Minister Tom Osborne is in support of the change and authored a petition which has been circulated in the community. In a community of 714 homes 860 signatures were collected and this is enclosed.

This project is not completed. Now is the time to correct the problem so that all involved can use the roadways safely. Our committee has a proposal that is a cost efficient and will widen the roadway. This is an opportunity to show our City council listens and are accepting of change when a community speaks in a respectful manor.
